Council Overview

The Transportation Planning Council (TPC) covers planning activities of transportation facilities systems for people and goods, assessing land-use impacts, trip generation, urban freeway removal, forecasting transportation needs and analyzing and evaluating transportation programs.

The TPC is one of the larger councils, with more than 1,000 members. Keeping up to date on transportation planning issues is one of the major benefits of TPC membership. TPC quarterly Executive Committee meetings and bi-annual Membership Meetings, ITE Community Posts, webinars, conference meeting posts and various technical quick bites and reports provide members with news, announcements, proposed legislation and regulations, opportunities to provide input, announcements of council projects and ways to become involved in those activities.

The TPC actively seeks out the most effective means of communicating with its members, and has a Discussion Group on ITE Community, where members can post technical questions and receive quick responses from their peers. The TPC has three (3) Standing Committees (Health, Sustainability, and Parking) that it coordinates efforts with and supports.

TPC will be an incubator of ideas and technical products in the transportation planning realm.

Social Responsibility Initiatives

Transportation Equity

In 2018, the Sustainability Standing Committee lead a series of various engagement efforts (webinars, ITE Journal articles, District Meetings, Podcasts) on the topic of Transportation Equity, as part of a larger initiative identified by the Coordinating Council in relation to best practices and areas for improvement in equitable transportation decision making and equitable representation in the transportation professionals' community. Our Committee in 2019 compiled the various conversations, member feedback, discussions, etc. on this topic from the aforementioned efforts as well as coordinated with the new ITE Diversity and Inclusion Task Force. In 2020, the Equity topic took center stage for the ITE Board of Direction which identified potential projects or steps the Institute could take as it relates to transportation equity. To that end, equity and inclusivity have become focal points of numerous councils and committees heading into 2021 the executive leadership of the Coordinating Council supported such initiatives on this topics through collaborations amongst the various councils and committees.

As part of this effort into 2021, ITE's Sustainability Standing Committee (SSC) led the effort to document and collect information and resources shared during each of the six (6) Transportation Equity Listening Sessions ITE hosted in 2021, synthesizing the discussions, capturing the conversations, making connections, and grouping similarities into this white paper for the ITE International Board of Direction's consideration in determining ITE's actions and effort on Transportation Equity.

We would look to continued collaboration/participation with the Equity working group on webinars/Annual Meeting presentations on equity in transportation from a sustainability lens. Now more than ever, the systematic issues and biases of our society that have been evident to people of color and low-economic standing for decades are forefront in the conversation. While historical decisions have had adverse effect on underrepresented populations, the transportation industry has shifted to attempt to correct for these historical practices and we are excited to be part of that discussion and a voice at the table for change.
